CALLS TO ACTION

WE CALL ON THE BC GOVERNMENT TO:

- Acknowledge the mental, emotional, spiritual, economic, and social harm done to local indigenous and nonindigenous communities, due to the Tailings Pond Dam Failure at Mount Polley Mine
- Organise a committee to oversee the compensation and restitution of these harmful results to affected indigenous and non-indigenous communities
- Introduce Legislation to codify into law a coporation's responsibility to fund the restitutions required by their negligence that resulted in environmental damage, destruction, or harm
- Fund the creation and development of an independant regulatory body to oversee the process of repairing damaged, destroyed, or harmed environments due to negligence
- Collaborate with the affected indigenous communities at every step of the process to repair these environments

The Mount Polley Mine Disaster affected over 20 First Nation Communities

The ?Esdilagh First Nation, Lhtako Dene First Nation, Nak'azdli Band, Simpcw First Nation, Sekw'el'wás First Nation, Spuzzum First Nation, Stswemecem'c Xgat'tem, T'it'q'et First Nation, T'exelcemc, T'eqt'aqtn'mux First Nation, T'it'q'et First Nation, Tl'azt'en Nation, Tl'esqox First Nation, Tl'etinqox First Nation, Tsal'alh First Nation, Tsi Deldel First Nation, Xaxli'p First Nation, Xat'sull First Nation, Xeni Gwet'in First Nation, Xwisten First Nation, and Yunesit'in Government all reported to be affected either emotionally, physically, spiritually, or economically.



This is just a single example of how the mining industry, and the BC Government has gotten away with infringing on and negatively affected indigenous rights.

The Mount Polley Mine Disaster occurred in 2014, wherein the tailings pond dam failed and resulted in about 25 billion litres of contaminated materials to spill into Quesnel Lake, Hazeltine Creek, and Polley Lake. Research studies have proven that these toxic tailings have become bio-available, despite the claims made by the mining company. As a key route to salmon spawning grounds, this is a huge ecological blow.

Furthermore, the local indigenous

Furthermore, the local indigenous communities have the right to subsist and part take in their traditional practices on these lands, which they may no longer be able to do because of this disaster. This clearly goes against the Government of BC's fiduciary duty to protect these rights. Mount Polley paid less than half of the cost to clean up their failed tailings pond, and have left BC taxpayers to pay the rest: over \$40 million.
